Unpaid entries will not be considered for the Draw.

General Guidelines

Corporate Tournament

- Teams or players, who arrive later than the scheduled start time, will forfeit games or face penalties. Please refer to the rules for each sport for further details per sport.
- Players are advised to adhere to playing all games in a fair and sportsman-like fashion.
- Any players found guilty of misconduct or misbehavior will be penalized. The organizer also reserves the right to disqualify a player's entire team from the sport and eject them from the premises.
- Please respect the venue(s). The venue(s) has its own guidelines for visitors and, as such all participants are required to adhere to these guidelines.
- Please do not litter.
- Please respect the referee's decisions.
- Any disputes arising during the competition must be taken up with the organizer in a cordial manner.
- If there are any disputes, they must be brought to the notice of tournament organizers within 10 MINUTES of game completion. Any disputes that are brought to the notice of the organizers after the 10 minutes elapse will not be entertained.
- A team/player that reports to the court any later than 5 minutes of the scheduled start of play will forfeit the game and the opponents (if present) will win with full points
- All events will run on a strict timetable. Competitors must be ready to play 20 (Twenty) minutes before the scheduled match time. If players are not ready to play at the scheduled time, they will be disqualified. Any changes to the schedule of play will be announced by the Referee



Corporate Tournament

1. Eligibility

Eligibility: *Any participant working with an Organisation (Own/Employed) who has a valid company ID can participate in the tournament. Company ID or salary slip will be verified at the registration desk. Doctors and all working professionals can participate in the tournament. (Badminton coaches and ranked players are not allowed to play in the tournament)

2. TOURNAMENT REGULATIONS

2.1 The Corporate Badminton Tournament is conducted by the Corporate Athletes and Retractable Club of Shaniwarwada, Pune.

2.2 Teams or players, who arrive later than the scheduled start time, will forfeit games or face penalties. Please refer to the rules for each sport for further details per sport.

2.3 The tournament will follow the Laws of Badminton strictly. The BWF General Competition Regulations (GCR) shall apply to the Championship to the extent of national tournament requirements, except for clothing and advertising.

2.4 In the event of any dispute, the decision of the Tournament Referee will be final.

2.5 The tournament will consist of five categories (differentiate groups) as given below.

2.5.1 Men's Singles [20+, 35+,45+]

2.5.2 Women's Singles [20+,35+,45+]

2.5.3 Men's Doubles [20+,35+,45+]

2.5.4 Womens Doubles

2.5.5 Mix Doubles

Minimum 8 entries in each category are mandatory to conduct matches otherwise the category will be canceled (T&C apply).

3. TOURNAMENT FORMAT / SCORING

3.1 Scoring System: 15 points X 3 games
(As per PDMBA Rule)

3.2 Withdrawal / Walkover: For these regulations, retiring from a match in a tournament, shall not be considered to be a withdrawal, however, should a Player be entered in more than one Event, by retiring or withdrawing from that one Event, the Player must be withdrawn from all other Events in which the Player is entered. (GCR 14.1.4).

3.3 Shuttles: Yonex Mavis 350

3.4 Service Law: The new Service Law, 9.1.6 shall be applicable. "9.1.6: the whole shuttle shall be below 1.15 meters from the surface of the court at the instant of being hit by the server's racket"

3.5 Clothing: From Quarter-Final onwards, opposing players shall wear different colors and for Doubles, each player in a given pair must wear shirts and shorts (or equivalent articles of clothing) of the same color and similar design throughout the match in accordance with the Summary Sheet for GCR 21 & 23 (BWF Statutes Section 5.3.7). No change of colors is allowed.

3.6 Line Judges: Organizers will not provide Line Judges. All participating players are obligated to volunteer as Line Judges whenever needed.

3.7 Doctor / Physio: Doctor / Physio will be available throughout the tournament to address on-court injuries. Off-Court Physio services will be available on a chargeable basis with a prior appointment.

4. COVID Norms: All players, coaches, and parents have to wear masks while entering the venue. The player shall wear the mask while entering the court for the match & also while leaving the court after the match.
